Introduction

Secretariat has been engaged in a sustained effort to meet and recruit new authorities to join SASIG in order to:

- Broaden the membership base
- Increase our influence as a strategic stakeholder within Government, with the CAA, the airport community and other important stakeholders
- Generate additional resources to support additional networking and strategic engagement opportunities, fund and publish independent and collaborative research and extend our outreach through briefing MPs and the media about local authority views on aviation issues.



Strategy

- In doing so we have focused initially on approaching authorities in:
 - The South West of England
 - The North of England
 - The Midlands
- We have also approached selected targets in London and South East
- In addition we have reached out to the GLA, the LGA's sister organisations in Scotland and Wales, Transport for the North, and the 19 strong Key Cities group of authorities
- And finally we have also written to nearly 300 MPs with airports in their constituencies asking whether they would be interested in receiving an abbreviated form of our Newletter.

Strategic Aviation

Broadening our appeal

- Our future plans involve:
 - Approaching authorities who have previously been members but will not be aware of the enhanced offer SASIG can now provide.
 - Focusing a little more on London and South East authorities
 - Filling in key gaps elsewhere in the country (e.g. West Yorkshire and the North West
- We also plan to approach the Core Cities group and the LEP network, in each case to seek their support for some or all of our policy agenda with the aim of working closely with them on these issues.
- We have plans, now our new website is operational, to offer affiliate status to Parish and Town Councils, Airport Consultative Committees representative business organisations and selected NGO.

The Recruitment Process

- Contact is initiated formally by e-mail to relevant Councillors (e.g. the Leader or Portfolio Holders) or Senior Officers, unless personal contacts or introductions are made.
- When interest is expressed a meeting is arranged which typically takes and hour, the aim being to take co-ordinate multiple meetings in a single focus area across one or two days
- Follow-up offers are typically requested in writing, or in some cases approaches are requested to other authorities before final commitments are made.
- Fees are being based on the existing membership rates but with introductory or multiple authority discounts as appropriate; thus far the fee structure has not appeared to be a problem.
